- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from **PHilMech** and inspect the Bidding Documents at the address given below from *8:00 am to 5:00 pm*.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **March 4 to March 24, 2026** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.

Payment of the required, non-refundable fee in the amount specified above shall be coordinated with our BAC Secretariat and may be paid in person or through electronic means (bank online deposit/transfer subject to the condition that the bank service charge will be shouldered by the bidder) by first securing a duly processed and verified/referenced Order of Payment from the PHilMech Finance Division prior payment of the required applicable fee to our Cashier/Collecting Officer. The original copy of Official Receipt (OR) evidencing payment of the bidding documents may be retrieved in person or may be sent through our delivery service provider, at the expense of the requesting bidder to the address stated in their request. The scanned copy of the OR may be emailed to the bidder, as requested.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
